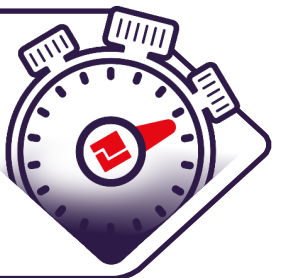

Evaluation

We review the relevant test and assessment evidence to provide a clearly defined scope for certification of the product.

Sampling / Testing

During the FPC audit, we will sample the products that are to be initial type tested (ITT) that will be used as evidence towards the product certification.

Ongoing Surveillance

A surveillance audit will be done annually to ensure that the FPC systems continue to meet the requirements of the scheme.

FPC Audit

A Factory Production Control (FPC) audit is performed at each site where the product is produced. The audit will be carried out in general accordance with ISO9001, along with the additional requirements of the UKTC ensure scheme.

Certification

The certificate is prepared based on supporting data, tests, and the results of the FPC audit. It will then be available to download via the UKTC ensure vault, along with supporting manufacturer information.

Audit Testing

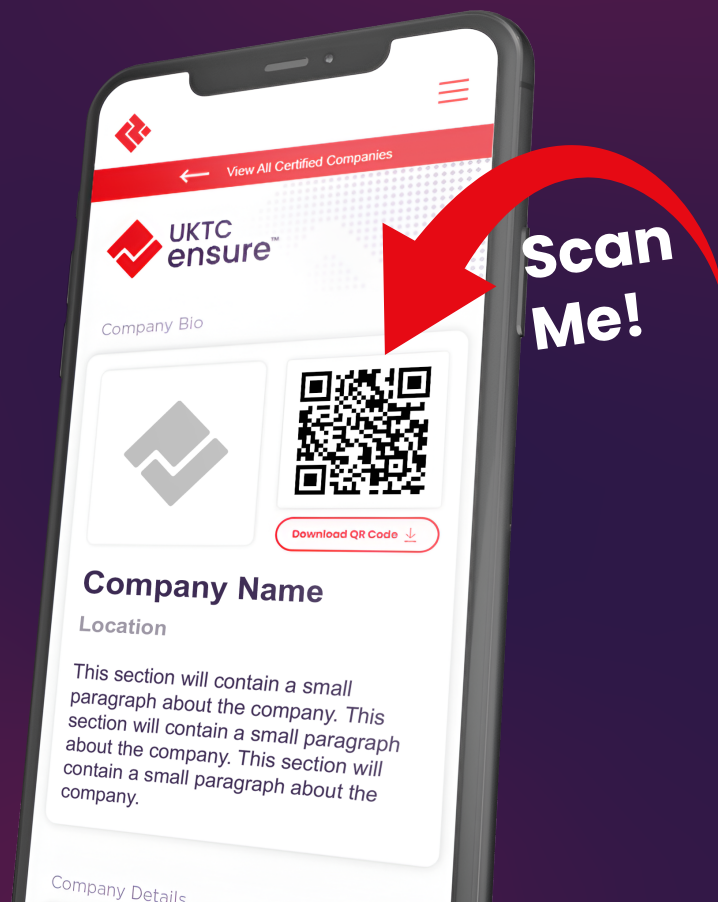
During the annual surveillance audit, samples will be selected for the required audit tests to ensure that the FPC system continues to satisfy the declared performance.

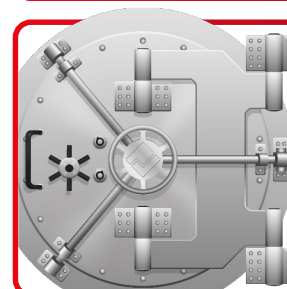

Three easy steps to **access information...**



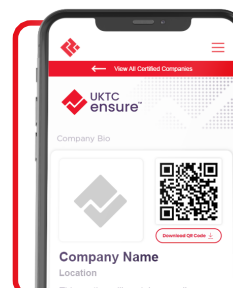
1. Scan QR Code on ensure label

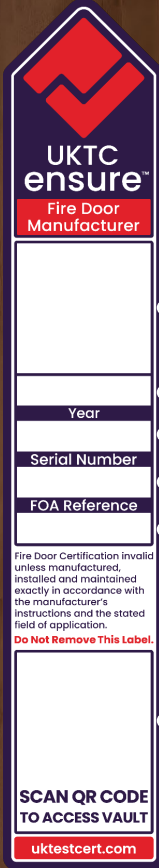
